In Memoriam: Henry Carroll Pusey

Mr. Henry Carroll Pusey, born October 13, 1927 in Seaford, Delaware, son of Samuel E. Pusey and Agnes May Giles Pusey, passed away on December 11, 2014 in Winchester, Virginia. He is predeceased by his wife, Sallie Cummings Pusey. He has four daughters: Cheryle Pusey Grier of Four Oakes, NC, Pamela L. Pusey and Diane Pusey Ball of Manassas, VA, and Sandra Pusey Encinias of Ashburn, VA; three grand-sons, Raymond and Mark Bryant of Zephyr Hills, FL, and Michael Encinias of Ashburn, VA; four grand-daughters, Connie Bryant McGann of Benson, NC, Elizabeth and Samantha Ball of Manassas, VA and Melissa Encinias of Ashburn, VA; three stepsons, Robert Houston White of Medford, Ma, Bruce Edward White of NJ, and Jay Michael White of Linden, VA; four greatgrandchildren, Amanda McGann, David McGann, Jr. and Brian McGann of Benson, NC, and Austin Bryant of Zephyr Hills, FL; two stepgrandsons and three step great grandsons.

Mr. Pusey graduated with honors in 1946 from Milford High School in Milford, Delaware. He was a WWI veteran with service at the Nuremburg War Crimes Trials. He graduated from Randolph Macon College in 1952 with a BS in Physics; he was elected to membership in Phi Beta Kappa. He was a Federal Employee in the Department of Defense for nearly 32 years, retiring in 1983 as Director of the Shock and Vibration Information Center at the U. S. Naval Research Laboratory. From 1983 until near the time of his death, he worked as an independent consultant in varied, but related, technical fields. In 1990 he became the Executive Director of the Society of Machinery Failure Prevention Technology (MFPT) with his wife, Sallie, as Office Manager until their retirement in 2006. In 1983 Henry was a principal organizer of the fiveday technical course on "Practical Shock Analysis and Design"; the course was very popular and was still being given in 2014. During his professional career he received numerous honors and awards. Most notably, the "Henry Pusey Award" was established in his honor to be presented for the "Best Paper" at the annual Shock and Vibration Symposia. Upon their retirement from the MFPT Society in 2006, Henry and his wife, Sallie received several Honors and Awards; the most notable were the establishment of the Henry and Sallie Pusey Best Paper Award to be presented at each Annual Meeting of the Society and the Proclamation by the Mayor of Virginia Beach designating April 4, 2006 as Henry and Sallie Pusey Day in that city. Henry and his wife, Sallie enjoyed working on family history. He was able to trace several of his ancestral lines to the 17th century and beyond. He was a member of the Virginia Society's Colonel James Wood, Jr. Chapter of the National Society Sons of the American Revolution and the National Society, Sons and Daughters of the Pilgrims. He is interred at Shenandoah Memorial Park, Frederick County, VA.
